- § 1. WHEREAS, an Outer Loop Major Investment Study (MIS) has been commissioned by the Association of Central Oklahoma Governments (ACOG), the Oklahoma Department of Transportation (ODOT), and the Oklahoma Turnpike Authority (OTA); and
- § 2. WHEREAS, a simultaneous study is being conducted regarding a possible Interstate 35 Trade Corridor Bypass around the Metropolitan Oklahoma City Area; and
- § 3. WHEREAS, the Council of the City of Norman recognizes citizens' concerns about the future development of Norman and the impact that any major transportation facility will have; and
- § 4. WHEREAS, the City Council at its meeting of February 25, 1997, reviewed and adopted the NORMAN 2020 Land Use and Transportation Plan which includes a proposed alignment for an Outer Loop generally consistent with the currently adopted OCARTS 2020 Plan for the same facility; and
- § 5. WHEREAS, there were Public Meetings held in Norman on June 16, 1998 for presentation and discussion of the Outer Loop Study and on December 8, 1998 for presentation and discussion of the selected "Viable Alternatives"; and
- § 6. WHEREAS, subsequent to these Public Meetings, the Mayor and City Council have received numerous inputs by citizens throughout Norman relative to the benefits and problems associated with the "Viable Alternatives" as proposed through the MIS process; and
- § 7. WHEREAS, any proposed Interstate 35 Trade Corridor Bypass and/or an Outer Loop alignment placed between the urbanized core of Norman and Lake Thunderbird would produce the most negative social, economic, and environmental impacts on the citizenry of Norman.
